Terms & Conditions:

Overview: Bed Bugs are small insects that feed on human blood. They are usually active at night when people are sleeping or sedentary. Adult Bed Bugs are big enough to be seen but often hide in cracks in furniture, floors and walls. A Bed Bug colony started with only one male & one female, that is not controlled, will commonly turn into an infestation of approximately 24,000 bed bugs within 14 weeks. Bed Bug infestations are commonly reported in homes, apartments, movie theaters, churches, hotels, airplanes, dormitories, shelters, schools and public transportation vehicles. Bed Bugs spread by "hitchhiking" on people, clothing & luggage.

Monitoring Program & Guarantee:

- Green Giant will first conduct a thorough inspection to determine if the property qualifies as "Bed Bug Free". Once the property is qualified <u>AND</u> the first payment is received by Green Giant, your Bed Bug Protection Plan will be in effect.
- Green Giant will provide Bed Bug monitors and place them at appropriate locations in the home.
- If, at any time that the Bed Bug Protection Plan is in effect, Bed Bug activity is discovered, Green Giant will provide Bed Bug treatment at no cost to the customer. The treatment will consist of Green Giant's standard Bed Bug control service.

Other information:

- If the customer's account is in arrears, the guarantee ceases to be in effect and the plan may be cancelled by Green Giant.
- If during the effective period of this Agreement, Green Giant, for whatever reason, changes the type of monitoring stations being used an appropriate alternative monitoring method will be determined by and performed by Green Giant at no charge to the Customer. The monitoring stations are not owned by the Customer and may be removed by Green Giant at its discretion, at any time, for replacement with an alternative treatment method, upon the termination of this Agreement or if Green Giant ceases to offer a monitoring program in this area.
- Monitors that are damaged, removed or disappear for any reason will be billed to the customer at the current price.
- Green Giant will work with and advise the customer of proper practices to avoid infestation of bed bugs. Green Giant
 reserves the right to cancel this agreement if it becomes apparent that bed bugs are being re-introduced to a property
 after a treatment is performed.

THIS AGREEMENT ONLY PROVIDES FOR THE TREATMENT OF A STRUCTURE FOR BED BUGS. CUSTOMER EXPRESSELY WAIVES ANY CLAIM FOR ECONOMIC, COMPENSATORY OR CONSEQUENTIAL DAMAGES RELATING TO A BED BUG INFESTATION.
